Dear Talks Team Members

I hope you all had good holidays and have returned ready for action in the Talks from September. For those who have been away, or who have been glad to avoid the Talks chaos so far, the progress has been very slow with only one real job done to date. The **Rules of Procedure** which will be applied during all the substantive discussions have now been agreed.

I have started an information bank for the use of the Women's Coalition, and the Talks Team in particular. It provides background to and specific information on various topics which will form part of the negotiations. Please feel free to come in to our offices in Castle Buildings and spend some time reading up on the issues.

It is suggested now that the procedural business is out of the way we have more regular Talks Team meetings - perhaps twice a month.

The first meeting will be on Tuesday 20 August from 11:30 am to 3:30 pm (with sandwich lunch). The purpose of this meeting will be to consider the agendas proposed by the British and Irish governments for the substantive Talks under the headings Strands One, Two and Three. Copies of these agendas are enclosed; please treat them as **very confidential**.

Following a short update at the meeting, we need to identify if there are any amendments, deletions or additions we wish to make to these agendas. We may also take the opportunity to do some brainstorming on possible elements under each agenda item to assist the preparation of our thinking for the discussions.

A number of other people have been invited to attend this meeting on 20 August to contribute to the discussions. A full list of invitees is enclosed. It is also proposed to build on this discussion by holding a series of meetings in the last week of August in Newry/Armagh; Enniskillen; Derry and Belfast attended by Monica, Pearl and other members as the Talks Team. Also, Pearl is arranging to meet with as many other delegations as possible to get their views on the proposed agendas.

Following this another meeting of the Talks Team will take place on Tuesday 3
September from 11:30 am to 3:30 pm (with sandwich lunch). On this occasion we will
need to finalise our views on the agendas and consider any alternative proposals
which the Women's Coalition might make in relation to them.

A summary of meeting dates is enclosed. Please let Ann McCann know at if you will be attending the two Talks Team meetings and your availability for the local meetings.



PROPOSED AGENDA FOR STRAND ONE ISSUES

- 1. Discussion of requirements for a new beginning for relationships within Northern Ireland.
- Consideration of possible principles and criteria for new arrangements within Northern Ireland.
- The question of institutional and other practical implications of these discussions.

Topics likely to arise include:

- The constitutional position of Northern Ireland;
- The nature of institutional arrangements for and within Northern Ireland, which meet any agreed criteria, including, nature and extent of powers eg legislative, executive, administrative; structures for exercising these powers; safeguards to maintain cross-community confidence and financial arrangements;
- The extent to which present or proposed arrangements attract the assent and support of both sides of the community and ensure equity of treatment;
- Relationships with other institutions eg Westminster Parliament, any new North/South relationships, any new Intergovernmental arrangements and the European Union;
- Consideration of arrangements for the protection of rights;
- law and order matters.

This list is not comprehensive and other issues may emerge in discussion.

PROPOSED AGENDA FOR STRAND TWO ISSUES

- Discussion of requirements for a new beginning for relationships within the island of Ireland, including fundamental aspects of the problem: underlying realities; identity; allegiance; constitutional.
- Common interests (including matters such as economic co-operation and development, security co-operation and law enforcement co-operation) and themes.
- The question of institutional arrangements and any other practical implications to meet agreed requirements (including principles to govern any such arrangements).
- Relationship of such new institutional arrangements to other structures eg: UK
 Government and Parliament; Irish Government and Parliament; Northern Ireland
 structures; Irish-UK intergovernmental structures; the European Union.
- Measures for the guarantee and protection of rights.
- Consequential measures needed to implement, support and underwrite such new structures.
- Report to Plenary.

PROPOSED AGENDA FOR STRAND THREE ISSUES

- Opening presentations by the two Governments.
- Establishment of necessary mechanisms to provide a meaningful role for the political parties in respect of Strand Three issues.
- Examination of the causes of the conflict in Northern Ireland, its impact and its implications for the two Governments.
- Principles and criteria which should underpin new arrangements, including requirements
 to acknowledge and recognise the rights of the two major traditions that exist in Ireland.
- The question of institutional arrangements and provisions of any new agreement or structure.
- Arrangements needed to implement, support and underwrite any new agreement or structure.
- Constitutional issues.
- 8. Consideration of arrangements for the protection of rights.
- Arrangements for the approval and implementation of a comprehensive agreement.
- Report to Plenary.
