BARRING ACCIDENTS THE COALITION LOOKS SET TO LAST FOR THE NEXT FOUR YEARS. THE SENIOR FIANNA FAIL FIGURES SACKED BY REYNOLDS EARLY LAST YEAR CONTINUE TO GRUMBLE ON THE BACKBENCHES: THOUGH INCREASINGLY IRRELEVANT, THE COULD BE DANGEROUS SHOULD REYNOLDS FALTER.

- FURTHER DIFFICULT ISSUES LIE AHEAD, NOTABLY THE REPORT OF

SPRING URGES THE NEED FOR A NEW ALL-EMBRACING ACCOMMODATION BETWEEN NATIONALISTS AND UNIONISTS UPON WHICH NEW POLITICAL STRUCTURES MIGHT BE BASED. HE IS FRUSTRATED BY MOLYNEAUX'S REFUSAL TO MEET HIM. REYNOLDS IS CONTENT TO LET SPRING TAKE THE LEAD. THOUGH THEY SEE GENERALLY EYE TO EYE, AND CONSULT CLOSELY AND OFTEN, REYNOLDS HAS JUDGED IT POLITICALLY NECESSARY ON OCCASION TO ECHO THE TRADITIONAL FIANNA FAIL REPUBLICAN LINE: THAT IT IS PRINCIPALLY FOR THE BRITISH GOVERNMENT TO PERSUADE UNIONISTS OF THE MERITS OF IRISH UNITY, ALBEIT IN THE VERY LONG TERM.

8. REYNOLDS WILL PURSUE THE TALKS WHILE THEY APPEAR A VIABLE OPTION. BUT HE IS OPEN TO FIANNA FAIL INFLUENCE OVER WHAT MIGHT COME NEXT, NOTABLY THE FAMILIAR LINE THAT THE IRISH SHOULD NEGOTIATE A SOLUTION WITH HMG AND PRESS THE NORTHERN IRELAND PARTIES TO ACCEPT IT. LIKE SPRING, HE WOULD DOUBTLESS ALSO FAVOUR USING THE ANGLO-IRISH AGREEMENT TO ENHANCE NATIONALIST INFLUENCE IN NORTHERN IRELAND.

- 9. THE LIKELY ISSUES FOR DISCUSSION ARE SUBSIDIARITY (OUR CHOICE) AND THE CASE AND PROSPECTS FOR A EUROPEAN COUNCIL IN THE AUTUMN. REYNOLDS REPORTEDLY TOLD THE VISITING DANISH PRIME MINISTER LAST WEEK THAT HE THOUGHT THE LATTER SUGGESTION PREMATURE AND UNNECESSARY. REYNOLDS WILL ALSO PROBABLY WANT TO REINFORCE THE IRISH CASE FOR ?8 BILLION IN STRUCTURAL FUNDS, A FIGURE BASED ON THE ASSUMPTION THAT THEY WILL GET THE SAME PROPORTION (13 PER CENT) OF THE TOTAL AGREED AT EDINBURGH AS THEY HAVE IN THE PAST: THERE HAVE RECENTLY BEEN SUGGESTIONS FROM BRUSSELS THAT THE SUM MIGHT NOT BE SECURE. HE WILL NO DOUBT SEEK THE PRIME MINISTER'S ASSESSMENT OF THE PROSPECTS FOR RATIFICATION OF THE MAASTRICHT TREATY.
- 10. FINALLY, IT WOULD BE WORTH PRESSING REYNOLDS ABOUT HIS REPORTED REMARKS IN PARIS LAST WEEK, WHEN HE APPEARED TO ENDORSE THE FRENCH LINE ON GATT. THE IRISH HAVE MORE THAN MOST TO LOSE FROM TRADE BARRIERS: EXPORTS REPRESENT 74 PER CENT OF IRISH GNP, IMPORTS SOME 61 PER CENT - AND 34 PER CENT OF EXPORTS ARE TO NON-EC MARKETS. HITHERTO THEY HAVE SAT ON THE FENCE.
