## NORTHERN IRELAND: PRESIDENT CLINTON'S TELEPHONE CALL

- We spoke this morning about the report in the Irish Times that Clinton had called the Prime Minister last week at the request of the Irish Government.
- 2. The Irish Embassy here claim they are innocent. They admit to having spoken to Conor O'Clery, author of the piece, who they say was inspired by newspaper accounts of Clinton's 'phone conversation with Kravchuk to ask whether there had been a call to the Prime Minister. Our State Department and NSC contacts believe that Dermot Gallagher had at least some responsibility for the Irish Times version of events. Mike Parmly, Deputy Director of State's Northern European Bureau, who follows Northern Ireland affairs closely, added that there were also those in the White House who wished Clinton's intervention to be seen as more one-sided than it had been. There was a continuing argument between the State Department, who saw the US role as currently limited to lending support to the efforts of the two governments within the framework of the AIG, and the NSC Staff Director, Nancy Soderberg, who believed that Clinton should be seen in a greener light. Parmly was pleased that briefings this morning in both London and Washington had revealed - in virtually identical terms - the constructive and balanced nature of the President's call to the Prime Minister.
- We spoke briefly about the possibility of Clinton making a further statement of support after the 3 December meeting. While it was important not to devalue the currency, State Department

/ Reuters' report, just received - might themselves be seen as a further message of support from Clinton. However, if it turned out that there was something to shout about on Friday evening - or if problems had arisen and a nudge from Washington might help to keep the process on the rails - the Administration would, be ready to help. We agreed to stay in touch.
