

In parallel with the invitations issuing to George Mitchell, John de Chastelain and Harri Holkeri, I would be grateful if the Prime Minister could send the attached messages to President Clinton, President Ahtisaari and Prime Minister Chretien as soon as practicable. If timing permits, they could also be sent a copy of the scenario of the opening plenary paper.

All three Chairmen will be invited in their personal capacity. Harri Holkeri and John de Chastelain are not employed by their Governments, but in both cases letters are a necessary courtesy. The message to President Clinton asks him to release George Mitchell, as he did for the International Body.

These negotiations present the best opportunity for many years to reach a settlement which can secure widespread acceptance amonst the parties and the people of Northern Ireland. I remain grateful to you personally and to your administration for your staunch support. You allowed us to make use of George Mitchell's talents to chair the International Body on decommissioning at the turn of the year, and we would be grateful if you would allow him to help once again and chair the important plenary sessions of the negotiations. I wish we had been in a position to formally invite him sooner, but the overall balance of the posts matters hugely to all sides - we believe the package is now an excellent one.

John Bruton and I have decided to invite all the group that worked so well under George's leadership on the International Body, and have invited John de Chastelain to chair the Strand Two negotiations, with Harri Holkeri acting as an alternate chairman in any of the independent chairmanship roles.

We have also agreed on the format of the opening plenary on Monday and [have published and I attach a copy of/will shortly be publishing] the details for the parties to see, as well as forwarding to them the draft agenda and procedural rules for the negotiations as a whole.

As I write, Sinn Fein continue to exclude themselves from this opportunity and have announced that they will boycott the Forum. They, and the IRA, are arguing that their election results alone give them the right to take part in Monday's negotiations. I deplore their stance and know that you do too. An unequivocal restoration of the 1994 IRA ceasefire is required.

We may have to continue our work against the backdrop of Sinn Fein media protests. This will not make negotiations any easier, but we remain committed to the success of those negotiations and I hope very much that George Mitchell will assist us.

I am writing to tell you that we have now made a formal approach to General de Chastelain to invite him to chair Strand Two of the negotiations on the future of Northern Ireland which start on 10 June. We had been in touch with him informally, and are grateful for his patience and willingness to help again.

As you will know, the recent elections were well-supported, with a high turn-out, and all the key negotiators, including the small loyalist parties, were elected. This lays the groundwork for the opening plenary session on 10 June, which we have asked George Mitchell to chair.

I remain grateful for your continuing support. We believe that these negotiations present the best opportunity for many years to

reach a settlement, but are under no delusions that they will be easy. As I write, Sinn Fein continue to exclude themselves from the negotiations. I deplore their stance, but their absence from the negotiating table will not prevent us pressing ahead to achieve progress.

As I write there has still been no restoration of IRA ceasefire, which is necessary for Sinn Fein to take their place at the table. I regret this, but both we and the Irish Government remain deeply committed to make progress, and look forward to working with Harri Holkeri.
