A1. Possible alternative to paragraph 15

15. The negotiations in the various formats, committees and sub-committees, will be on the basis of a comprehensive agenda for the negotiations as a whole, adopted by agreement in the opening plenary. Without prejudice to any participant's negotiating position, that agenda will be such as to enable each participant to raise any significant issue of concern to them and to receive a fair hearing for those concerns without their ability to do so being subject to the veto of any other party in the negotiations. Participants may, by agreement, develop or refine the comprehensive agenda.

A2. Possible alternative to paragraph 30

30. The British Government, as Chairman of Strand One, will keep the Irish Government informed through liaison arrangements agreed between the two Governments and will report the progress which Strand One participants agree has been made.

TALKS: MONDAY 1 JULY 1996

Another day of repetitious circular argument. Despite Chairman's hopes of completing more, only amendments tabled by the two Governments considered. No proposals about scheduling aired in conferral session, but Chairman tells two Governments that he is thinking of proposing that talks should take place on three days next week; that talks should resume on 15 July after the twelfth holiday and that work should continue until 21 July at the earliest.
