AN ACT TO AMEND THE CONSTITUTION BY INSERTING THEREIN SPECIAL PROVISION FOR THE ELECTION AT A GENERAL ELECTION OF THE MEMBER OF DAIL EIREANN WHO WAS CHAIRMAN THEREOF IMMEDIATELY BEFORE THE PRECEDING DISSOLU-TION OF THE OIREACHTAS.

BE IT ENACTED BY THE OIREACHTAS OF SAORSTAT 20 EIREANN AS FOLLOWS :-

1.-The Constitution shall be and is hereby amended by the Re-election at insertion therein of the following paragraph at the end of and as general election an addition to Article 21, that is to say :-

Dáil Eireann immediately before the dissolution of the Oireachtas shall, unless before such dissolution he announces to Dáil Eireann that he does not desire to continue to be a member thereof, be deemed without any actual election to be elected at the ensuing general election as an additional

member of Dáil Eireann not representing any constituency and shall as such additional member have all the rights and obligations of an ordinary member of Dáil Eireann (including eligibility for the office of Chairman) save that his death, resignation, or disqualification shall not create a vacancy

2.-The Constitution shall be and is hereby amended by the Consequential insertion of the words "Save as is otherwise provided by amendment of Article 21 of this Constitution " in Article 26 thereof immediately Article 26. 40 before the words "Dáil Eireann " where those words first occur in that Article.
