15 AN ACT TO AMEND THE CONSTITUTION BY INSERTING
THEREIN SPECIAL PROVISION FOR THE ELECTION
AT A GENERAL ELECTION OF THE MEMBER OF
DÁIL ÉIREANN WHO WAS CHAIRMAN THEREOF
IMMEDIATELY BEFORE THE PRECEDING DISSOLU-
TION OF THE OIREACHTAS.

20 BE IT ENACTED BY THE OIREACHTAS OF SAORSTAT
ÉIREANN AS FOLLOWS:—

1.—The Constitution shall be and is hereby amended by the
insertion therein of the following paragraph at the end of and as
an addition to Article 21, that is to say:—

Re-election at
general election
of outgoing
Chairman of
Dáil Éireann.

25 “The member of Dáil Éireann who is the Chairman of
Dáil Éireann immediately before a dissolution of the
Oireachtas shall, unless before such dissolution he announces
to Dáil Éireann that he does not desire to continue to be a
member thereof, be deemed without any actual election to
30 be elected in accordance with this Constitution at the ensuing
general election as a member of Dáil Éireann for the con-
stituency for which he was a member immediately before
such dissolution or, in the event of a revision of constituen-
cies having taken place, for the revised constituency declared
35 on such revision to correspond to such first-mentioned
constituency. Whenever a former Chairman of Dáil Éireann
is so deemed to have been elected at a general election as a
member for a constituency the number of members actually
to be elected for such constituency at such general election
40 shall be one less than would otherwise be required to be
elected therefor.”

2.—This Act may be cited as the Constitution (Amendment Short title.
No. 2) Act, 1926.
