BE IT ENACTED BY THE OIREACHTAS OF SAORSTAT 20 EIREANN AS FOLLOWS :-

1.—The Constitution shall be and is hereby amended by the Re-election at insertion therein of the following paragraph at the end of and as general election an addition to Article 21, that is to say :-

of outgoing Chairman of Dáil Eireann.

"The member of Dáil Éireann who is the Chairman of Dáil Éireann immediately before a dissolution of the 25 Oireachtas shall, unless before such dissolution he announces to Dáil Éireann that he does not desire to continue to be a member thereof, be deemed without any actual election to be elected in accordance with this Constitution at the ensuing 30 general election as a member of Dáil Éireann for the constituency for which he was a member immediately before such dissolution or, in the event of a revision of constituencies having taken place, for the revised constituency declared on such revision to correspond to such first-mentioned constituency. Whenever a former Chairman of Dáil Éireann 35 is so deemed to have been elected at a general election as a member for a constituency the number of members actually to be elected for such constituency at such general election shall be one less than would otherwise be required to be 40 elected therefor."
