BE IT ENACTED BY THE OIREACHTAS OF SAORSTAT EIREANN AS FOLLOWS :-

 The Constitution shall be and is hereby amended by the Increase of deletion from Article 51 thereof of the words "not more than membership of seven" and the insertion in that Article of the words "not more Council. than twelve " in lieu of the said words so deleted.

2.-This Act may be cited as the Constitution (Amendment Short title. No. 5) Act, 1926.
