BE IT ENACTED BY THE OIREACHTAS OF SAORSTAT
EIREANN AS FOLLOWS:—

20 1.—The Constitution shall be and is hereby amended by the
deletion from Article 51 thereof of the words “not more than
seven” and the insertion in that Article of the words “not more
than twelve” in lieu of the said words so deleted.
