AN ACT TO AMEND THE CONSTITUTION BY REMOVING

BE IT ENACTED BY THE OIREACHTAS OF SAORSTAT  
EIREANN AS FOLLOWS:—

1.—The Constitution shall be and is hereby amended by the Cesser of  
deletion from Article 28 thereof of the words “and shall be holiday for  
proclaimed a public holiday.” general election.

2.—This Act may be cited as the Constitution (Amendment Short title.  
No. 3) Act, 1926.
