AN ACT TO AMEND THE CONSTITUTION BY CONFINING
THE RIGHTS OF DEMANDING THE SUSPENSION 15
OF A BILL CONFERRED ON MEMBERS OF THE
OIREACHTAS BY ARTICLE 47 TO THOSE MEMBERS
WHO HAVE TAKEN THE OATH PURSUANT TO
ARTICLE 17 AND BY DELETING THE PROVISIONS
RELATING TO THE INITIATION BY THE PEOPLE OF 20
PROPOSALS FOR LAWS OR CONSTITUTIONAL
AMENDMENTS.

BE IT ENACTED BY THE OIREACHTAS OF SAORSTÁT
ÉIREANN AS FOLLOWS:—

1.—The Constitution shall be and is hereby amended by the 25
deletion from Article 14 thereof of the words “ and Initiative.”

2.—Article 47 of the Constitution shall be and is hereby
amended as follows, that is to say:—

(a) by the insertion therein of the words “ who have since
their last election thereto taken in the manner pre- 30
scribed by Article 17 of this Constitution the oath re-
quired by that Article to be taken by members of the
Oireachtas ” immediately after the words “ two-fifths
of the members of Dáil Éireann,” and

(b) by the insertion therein of the words “ who have since 35
their last election thereto taken in the manner afore-
said the said oath ” immediately after the words “ a
majority of the members of Seanad Éireann.”

3.—The Constitution shall be and is hereby amended by the 40
deletion of Article 48 thereof.

4.—This Act may be cited as the Constitution (Amendment No.
6) Act, 1927.

An Act to amend the Constitution by confining the rights of demanding the suspension of a Bill conferred on Members of the Oireachtas by Article 47 to those members who have taken the oath pursuant to Article 17 and by deleting the provisions relating to the initiation by the people of proposals for laws or constitutional amendments.
