15 BE IT ENACTED BY THE OIREACHTAS OF SAORSTÁT  
ÉIREANN AS FOLLOWS:—

1.—Article 31 of the Constitution shall be and is hereby Amendment of  
amended by the deletion of the word “thirty-five” now Article 31.  
contained therein and the insertion of the word “thirty” in lieu  
20 of the word so deleted.

2.—This Act may be cited as the Constitution (Amendment Short title.  
No. 8) Act, 1928.
