BE IT ENACTED BY THE OIREACHTAS OF SAORSTAT EIREANN AS FOLLOWS:—

1.—Article 39 of the Constitution shall be and is hereby amended by the deletion of the last sentence now contained therein, that is to say, the sentence beginning with the words "If rejected" and ending with the word "motion."

2.—This Act may be cited as the Constitution (Amendment No. 14) Act, 1928.
