AN ACT TO AMEND THE PROVISIONS OF ARTICLE 52 OF
15 THE CONSTITUTION REQUIRING THAT THE MEM-
BERS OF THE EXECUTIVE COUNCIL SHALL ALL BE
MEMBERS OF DAIL EIREANN BY PROVIDING THAT
THE MEMBERS OF THE EXECUTIVE COUNCIL
SHALL BE MEMBERS OF DAIL EIREANN. SAVE
20 THAT ONE MAY BE A MEMBER OF SEANAD
EIREANN AND BY MAKING CONSEQUENTIAL
PROVISION IN THE CONSTITUTION AS TO THE
RIGHT OF ATTENDANCE AND AUDIENCE OF MINIS-
TERS AT AND IN THE HOUSES OF THE OIREACHTAS.

BE IT ENACTED BY THE OIREACHTAS OF SAORSTÁT
25 EIREANN AS FOLLOWS:—

1.—The Constitution shall be and is hereby amended by the deletion of Article 52 now contained therein and the insertion in lieu of the said Article 52 of the following Article, that is to say:—

30 “ 52. The Ministers who form the Executive Council shall include the President of the Council, the Vice-President of the Council, and the Minister in charge of the Department of Finance. The President of the Council, the Vice-President of the Council, the Minister in charge of the Department of
35 Finance, and the other members of the Executive Council shall be members of Dáil Eireann, save that one of such other members may be a member of Seanad Eireann.”

2.—Article 57 of the Constitution shall be and is hereby amended by the insertion in the said Article after the words
40 “ Seanad Eireann ” now contained therein of the words “ and in Dáil Eireann.”

An Act to amend the provisions of Article 52 of the Constitution requiring that the members of the Executive Council shall all be members of Dáil Éireann by providing that the members of the Executive Council shall be members of Dáil Éireann save that one may be a member of Seanad Éireann, and by making consequential provision in the Constitution as to the right of attendance and audience of Ministers at and in the Houses of the Oireachtas.
