AN ACT TO AMEND THE PROVISIONS OF ARTICLE 52 OF THE CONSTITUTION REQUIRING THAT THE MEM-BERS OF THE EXECUTIVE COUNCIL SHALL ALL BE MEMBERS OF DAIL EIREANN BY PROVIDING THAT CERTAIN MEMBERS OF THE EXECUTIVE COUNCIL SHALL BE MEMBERS OF DAIL EIREANN AND THAT THE REMAINDER SHALL BE MEMBERS OF THE OIREACHTAS AND BY MAKING CONSEQUENTIAL PROVISION IN THE CONSTITUTION AS TO THE RIGHT 20 OF ATTENDANCE AND AUDIENCE OF MINISTERS AT AND IN THE HOUSES OF THE OIREACHTAS.

BE IT ENACTED BY THE OIREACHTAS OF SAORSTAT EIREANN AS FOLLOWS:-

1.—The Constitution shall be and is hereby amended by the Amendment of deletion of Article 52 now contained therein and the insertion in Article 52. lieu of the said Article 52 of the following Article, that is to 30 say :-

- "52. The Ministers who form the Executive Council shall include the President of the Council, the Vice-President of the Council, and the Minister in charge of the Department of Finance. The President of the Council, the Vice-President of the Council, and the Minister in charge of the Department of Finance shall be members of Dáil Eireann and all other members of the Executive Council shall be members of the Oireachtas."
- 2.—Article 57 of the Constitution shall be and is hereby Amendment of amended by the insertion in the said Article after the words Article 57, "Seanad Eireann" now contained therein of the words " and in Dáil Eireann."
- 3 .- This Act may be cited as the Constitution (Amendment Short title. No. 15) Act, 1928.

An Act to amend the provisions of Article 52 of the Constitution requiring that the members of the Executive Council shall all be members of Dáil Eireann by providing that certain members of the Executive Council shall be members of Dáil Eireann and that the remainder shall be members of the Oireachtas and by making consequential provision in the Constitution as to the right of attendance and audience of Ministers at and in the Houses of the Oireachtas.
