AN ACT TO AMEND THE PROVISIONS OF ARTICLE 52 OF
THE CONSTITUTION REQUIRING THAT THE MEM-
BERS OF THE EXECUTIVE COUNCIL SHALL ALL BE
15 MEMBERS OF DAIL ÉIREANN BY PROVIDING THAT
CERTAIN MEMBERS OF THE EXECUTIVE COUNCIL
SHALL BE MEMBERS OF DAIL ÉIREANN AND THAT
THE REMAINDER SHALL BE MEMBERS OF THE
20 OIREACHTAS AND BY MAKING CONSEQUENTIAL
PROVISION IN THE CONSTITUTION AS TO THE RIGHT
OF ATTENDANCE AND AUDIENCE OF MINISTERS AT
AND IN THE HOUSES OF THE OIREACHTAS.

25 BE IT ENACTED BY THE OIREACHTAS OF SAORSTAT
ÉIREANN AS FOLLOWS:—

1.—The Constitution shall be and is hereby amended by the
deletion of Article 52 now contained therein and the insertion in
lieu of the said Article 52 of the following Article, that is to
30 say:—

Amendment of
Article 52.

“ 52. The Ministers who form the Executive Council shall
include the President of the Council, the Vice-President of
the Council, and the Minister in charge of the Department
of Finance. The President of the Council, the Vice-President
35 of the Council, and the Minister in charge of the Department
of Finance shall be members of Dáil Éireann and all other
members of the Executive Council shall be members of the
Oireachtas.”

40 2.—Article 57 of the Constitution shall be and is hereby
amended by the insertion in the said Article after the words
“ Seanad Éireann ” now contained therein of the words “ and in
Dáil Éireann.”

An Act to amend the provisions of Article 52 of the Constitution requiring that the members of the Executive Council shall all be members of Dáil Éireann by providing that certain members of the Executive Council shall be members of Dáil Éireann and that the remainder shall be members of the Oireachtas and by making consequential provision in the Constitution as to the right of attendance and audience of Ministers at and in the Houses of the Oireachtas.
