AN ACT TO AMEND THE CONSTITUTION BY EXTENDING THE PERIOD WITHIN WHICH AMENDMENTS OF THE CONSTITUTION MAY BE MADE BY THE OIREACHTAS WITHOUT SUBMISSION THEREOF TO A REFERENDUM OF THE PEOPLE.

BE IT ENACTED BY THE OIREACHTAS OF SAORSTAT EIREANN AS FOLLOWS:—

1.—Article 50 of the Constitution shall be and is hereby amended by the deletion therefrom of the words “eight years” in each of the places in which those words now occur therein and the insertion in each case of the words “sixteen years” in lieu of the words so deleted; and the said Article 50 shall be construed and have effect accordingly.
