AN ACT TO EFFECT CERTAIN AMENDMENTS OF THE CONSTITUTION IN RELATION TO THE EXECUTIVE AUTHORITY AND POWER AND IN RELATION TO THE PERFORMANCE OF CERTAIN EXECUTIVE FUNC-TIONS.

BE IT ENACTED BY THE OIREACHTAS OF SAORSTAT EIREANN AS FOLLOWS:--

Amendments of the Constitution. 1.—The several Articles of the Constitution mentioned in the first column of the Schedule to this Act are hereby severally and respectively amended or otherwise dealt with in the manner 15 stated in the second column of the said Schedule opposite the mention of each such Article in the said first column.

Short title.

2.—This Act may be cited as the Constitution (Amendment No. 27) Act, 1936.
