AN ACT TO AMEND THE CONSTITUTION.

WHEREAS by virtue of Article 46 of the Constitution any provision of the Constitution may be amended in the manner provided by that Article:

AND WHEREAS it is proposed to amend Article 35 of the Constitution:

BE IT THEREFORE ENACTED BY THE OIREACHTAS AS FOLLOWS:

Amendment of Article 35 of the Constitution.

1.—Article 35 of the Constitution is hereby amended as follows:

- (a) the section, the text of which is set out in *Part 1* of the *Schedule*, shall be substituted for section 5 of the Irish text; and
- (b) the section, the text of which is set out in *Part 2* of the *Schedule*, shall be substituted for section 5 of the English text.

Citation.

2.—(1) The amendment of the Constitution effected by this Act shall be called the Twenty-Ninth Amendment of the Constitution.

(2) This Act may be cited as the Twenty-Ninth Amendment of the Constitution (Judges' Remuneration) Act 2011.

- 5 1° The remuneration of judges shall not be reduced during their continuance in office save in accordance with this section.
- 20 2° The remuneration of judges is subject to the imposition of taxes, levies or other charges that are imposed by law on persons generally or persons belonging to a particular class.
- 25 3° Where, before or after the enactment of this section, reductions have been or are made by law to the remuneration of persons belonging to classes of persons whose remuneration is paid out of public money and such law states that those reductions are in the public interest, provision may also be made by law to make proportionate reductions to the remuneration of judges.
