#### AN ACT TO AMEND THE CONSTITUTION.

WHEREAS by virtue of Article 46 of the Constitution any provision of the Constitution may be amended in the manner provided by the Article:

AND WHEREAS it is provided by Article 51 of the Constitu- 10 tion that any of the provisions of the Constitution may, subject as thereinafter provided, be amended by the Oireachtas within a period of three years after the date on which the first President shall have entered upon his office:

AND WHEREAS the first President entered upon his office on 15 the 25th day of June, 1938:

AND WHEREAS it is expedient to amend the provisions of Article 35 of the Constitution in manner hereinafter appearing.

BE IT THEREFORE ENACTED BY THE OIREACHTAS AS FOLLOWS:-

1.—Sub-section 1 of section 4 of Article 35 of the Constitution shall be and is hereby repealed and in lieu thereof a new subsection shall be inserted as follows:-

Enactment of the Amendment.

1º A Judge of the Supreme Court or the High Court or of any other Court established in pursuance of Article 34 hereof shall 25 not be removed from office except for stated misbehaviour or incapacity and then only upon resolutions calling for his removal passed by Dáil Eireann and by Seanad Eireann and for the passing of which not less than two-thirds (exclusive of the Chairman or presiding member of Dáil Eireann and of Seanad Eireann) of 30 the full membership of Dáil Eireann and of Seanad Eireann shall have voted. No such resolution shall be passed until a report upon the alleged misbehaviour or incapacity has been received from the Judges of the Supreme Court or the majority of them sitting as a Committee to investigate the same and approving of 35 the proposed removal. In case such proposed resolution shall relate to the conduct or capacity of a Judge of the Supreme Court such Judge shall not act upon such Committee but instead the Senior Judge of the High Court able and willing to act shall sit on such Committee.

2.—This Act may be cited as the Third Amendment of the Constitution Act, 1941.
