AN ACT TO AMEND THE CONSTITUTION.

WHEREAS by virtue of Article 46 of the Constitution any provision of the Constitution may be amended in the manner provided by that Article:

AND WHEREAS it is proposed to amend Article 16 of the Constitution:

BE IT THEREFORE ENACTED BY THE OIREACHTAS AS 10
FOLLOWS:

Amendment
of Article 16
of the
Constitution.

1.—Article 16 of the Constitution is hereby amended as follows:—

(a) “ocht mbliadhna déag” shall be substituted for “bliadhain agus fisce” in subsection 2° of section 1 of the Irish text,

(b) “eighteen years” shall be substituted for “twenty-one years” in subsection 2° of section 1 of the English text.

Citation.

2.—(1) The amendment of the Constitution effected by this Act shall be called the Fourth Amendment of the Constitution.

(2) This Act may be cited as the Fourth Amendment of the 20 Constitution Act, 1972.
