AN ACT TO AMEND THE CONSTITUTION.

WHEREAS by virtue of Article 46 of the Constitution any provision 5
of the Constitution may be amended in the manner provided by that
Article:

AND WHEREAS it is proposed to amend Article 40 of the
Constitution:

BE IT THEREFORE ENACTED BY THE OIREACHTAS AS 10
FOLLOWS:

Amendment of
Article 40 of the
Constitution.

1.—Article 40 of the Constitution is hereby amended as follows:

- (a) the subsection set out in *Part I* of the Schedule to this Act 5
shall be added to section 3 of the Irish text,
- (b) the subsection set out in *Part II* of the Schedule to this Act 15
shall be added to section 3 of the English text.

Citation.

2.—(1) The amendment of the Constitution effected by this Act
shall be called the Eighth Amendment of the Constitution.

(2) This Act may be cited as the Eighth Amendment of the Con- 20
stitution Act, 1982.
