AN ACT TO AMEND THE CONSTITUTION.

WHEREAS by virtue of Article 46 of the Constitution any provision 5
of the Constitution may be amended in the manner provided by that
Article:

AND WHEREAS it is proposed to amend Article 16 of the
Constitution:

BE IT THEREFORE ENACTED BY THE OIREACHTAS AS 10
FOLLOWS:

Amendment of
Article 16 of the
Constitution.

1.—Article 16 of the Constitution is hereby amended as follows:

- (a) the subsection set out in *Part I* of the Schedule to this Act
shall be substituted for subsection 2° of section 1 of the
Irish text, 15
- (b) the subsection set out in *Part II* of the Schedule to this Act
shall be substituted for subsection 2° of section 1 of the
English text,
- (c) “a dhícháileochadh saoránach ar bith nó duine ar bith eile,
ar an bhforas céanna sin,” shall be inserted after “de Dháil 20
Éireann nó” in subsection 3° of section 1 of the Irish text,
- (d) “or other person” shall be inserted after “disqualifying any
citizen” in subsection 3° of section 1 of the English text.

Citation.

2.—(1) The amendment of the Constitution effected by this Act
shall be called the Ninth Amendment of the Constitution. 25

(2) This Act may be cited as the Ninth Amendment of the Constitu-
tion Act, 1984.

1.—Leasaítear leis seo mar a leanas Airteagal 16 den Bhunreacht:

- (a) cuirfear an fo-alt atá leagtha amach i *gCuid I* den Sceideal a ghabhann leis an Acht seo in ionad fho-alt 2° d'alt 1 den téacs Gaeilge,
