AN ACT TO AMEND THE CONSTITUTION.

WHEREAS by virtue of Article 46 of the Constitution any provision of the Constitution may be amended in the manner provided by that Article:

AND WHEREAS it is proposed to amend Article 41 of the Constitution:

BE IT THEREFORE ENACTED BY THE OIREACHTAS AS FOLLOWS:

Amendment of Article 41 of the Constitution.

1.—Article 41 of the Constitution is hereby amended as follows:

- (a) the subsection set out in *Part I* of the Schedule to this Act shall be substituted for subsection 2° of section 3 of the 15 Irish text,
- (b) the subsection set out in *Part II* of the Schedule to this Act shall be substituted for subsection 2° of section 3 of the English text.

Citation.

2.—(1) The amendment of the Constitution effected by this Act 20 shall be called the Fifteenth Amendment of the Constitution.

(2) This Act may be cited as the Fifteenth Amendment of the Constitution Act, 1995.

- 2° A Court designated by law may grant a dissolution of marriage where, but only where, it is satisfied that— 20
- i. at the date of the institution of the proceedings, the spouses have lived apart from one another for a period of, or periods amounting to, at least four years during the previous five years,
 - ii. there is no reasonable prospect of a reconciliation between the spouses, 25
 - iii. such provision as the Court considers proper having regard to the circumstances exists or will be made for the spouses, any children of either or both of them and any other person prescribed by law, and 30
 - iv. any further conditions prescribed by law are complied with.
