# **BILL**

*entitled*

AN ACT TO AMEND THE CONSTITUTION.

5

WHEREAS by virtue of Article 46 of the Constitution any provision of the Constitution may be amended in the manner provided by that Article:

AND WHEREAS it is proposed to amend Article 29 of the Constitution:

10

BE IT THEREFORE ENACTED BY THE OIREACHTAS AS FOLLOWS:

Amendment of Article 29 of the Constitution.

**1.**—Article 29 of the Constitution is hereby amended as follows:

- (a) the section the text of which is set out in *Part 1* of the *Schedule* to this Act shall be inserted after section 8 of 15 the Irish text,
- (b) the section the text of which is set out in *Part 2* of the *Schedule* to this Act shall be inserted after section 8 of the English text.

Citation.

**2.**—(1) The amendment of the Constitution effected by this Act 20 shall be called the Twenty-third Amendment of the Constitution.

(2) This Act may be cited as the Twenty-third Amendment of the Constitution Act, 2001.
