AN ACT TO AMEND THE CONSTITUTION.

WHEREAS by virtue of Article 46 of the Constitution any provision of the Constitution may be amended in the manner provided by that Article:

AND WHEREAS it is proposed to amend Articles 12 and 16 of the Constitution:

BE IT THEREFORE ENACTED BY THE OIREACHTAS AS FOLLOWS:

Amendment of
Articles 12 and 16
of the Constitution.

1.—(1) Article 12 of the Constitution is hereby amended as follows:

(a) “ocht mbliana déag slán” shall be substituted for “cúig bliadhna tríochad slán” in subsection 1° of section 4 of the Irish text,

(b) “the age of eighteen years” shall be substituted for “his thirty-fifth year of age” in subsection 1° of section 4 of the English text.

(2) Article 16 of the Constitution is hereby amended as follows:

(a) “ocht mbliana déag” shall be substituted for “bliadhain agus fiche” in subsection 1° of section 1 of the Irish text,

(b) “eighteen years” shall be substituted for “twenty-one years” in subsection 1° of section 1 of the English text.

Citation.

2.—(1) The amendment of the Constitution effected by this Act shall be called the Twentieth Amendment of the Constitution.

(2) This Act may be cited as the Twentieth Amendment of the Constitution Act, 1999.

(b) cuirfear “eighteen years” in ionad “twenty-one years” i bhfo-alt 1° d’alt 1 den téacs Sacs-Bhéarla.
