AN ACT TO AMEND THE CONSTITUTION. 5

WHEREAS by virtue of Article 46 of the Constitution any provision of the Constitution may be amended in the manner provided by that Article:

AND WHEREAS it is proposed to amend Article 29 of the Constitution: 10

BE IT THEREFORE ENACTED BY THE OIREACHTAS AS FOLLOWS:

Amendment of
Article 29 of the
Constitution.

1.—Article 29 of the Constitution is hereby amended as follows:

- (a) section 2 shall be inserted as subsection 2° of section 1,
- (b) the subsection the text of which is set out in *Part 1* of the 15
Schedule to this Act shall be inserted as paragraph (ii) of
subsection 2° of section 4 of the Irish text,
- (c) the subsection the text of which is set out in *Part II* of the
Schedule to this Act shall be inserted as paragraph (ii) of
subsection 2° of section 4 of the English text. 20

Citation.

2.—(1) The amendment of the Constitution effected by this Act shall be called the Twenty-First Amendment of the Constitution.

(2) This Act may be cited as the Twenty-First Amendment of the Constitution Act, 1999.
