Thank you for yesterday's note instructing TAU to stay neutral and advising that all the Labour representatives are entitled to be present and to use their delegation suite. I am also grateful to John McKervill and Alan McVeigh for making themselves available yesterday morning to support Mr Lennox.

2. I have now received formal notification from Mark Langhammer that he will be taking the place of Malachi Curran in the existing talks team and that Dr Pat Muldowney will be Labour's Office Manager with effect from Monday, 8 July.

3. Mr Langhammer has asked TAU to pay allowances etc only into the account of the Labour Co-ordinating Committee and he also advises that Dr Muldowney has been authorised by him to make all claims for party and personal allowances, research grants and expenses. Finally he states that no one other than himself and Muldowney is authorised to do so.
