STATEMENT BY SENATOR GEORGE J MITCHELL  
GENERAL JOHN de CHASTELAIN, AND  
PRIME MINISTER HARRI HOLKERI

29 July 1996

The Opening Plenary Session of the multi-party negotiations resumed today at Castle Buildings, Belfast.

After discussion, participants agreed and adopted the rules of procedure for the conduct of the negotiations.

The participants also agreed to the establishment of the Business Committee.

We believe this represents significant progress.

Following the morning meeting of the Plenary, constructive talks on the agenda for the remainder of Opening Plenary session took place. We have found common ground and have identified some differences. In the view of the Chairmen, it is not possible to reach agreement on this issue at this time. We believe, therefore, that all participants would benefit from a period for reflection.

Consequently, the Opening Plenary stands adjourned until September 9, 1996. During the interim, we suggest that all participants reflect on the agenda and return determined to resolve it quickly at the outset.

We remain firm in our view that these talks are the best means of securing a broadly acceptable political solution and lasting peace in Northern Ireland. We look forward to continuing our work with the participants to move toward that goal.
