**IBEC/CBI "JOINT BUSINESS COUNCIL" DOCUMENT: "THE SINGLE MARKET, RECOMMENDATIONS FOR THE IRISH PRESIDENCY"**

### Background

1. Mr William Poole, Business Development Programme Director of the "Joint Business Council [a partnership of IBEC and the CBI] has written to Baroness Denton enclosing a copy of the above titled paper seeking the Minister's support on the issues raised and asking for a meeting with her to discuss same.
2. Most of the issues raised in the paper are outside the immediate control of the Department of Economic Development and thus it is necessary to circulate the document to relevant officials to allow them to study the contents and provide briefing and advice as appropriate.

### Action
