## July 23, 1857.] CONSTITUTIONAL CONVENTION.

Constitutional Convention—without any legal authority or right, although some of those connected with that assemblage may be entitled to seats in this Convention, but who have not seen proper as yet to present their credentials or to attend the meetings of this body, since the regular adjournment of the Convention on Monday the thirteenth instant, therefore,

"Resolved, That the assemblage of persons now occupying the Representatives' Hall, of this Capitol, styling themselves the Constitutional Convention,' is without the authority of law or, of parliamentary usage, and revolutionary in its character, and therefore should not be recognized by the electors of this Territory, nor the officers of the general or Territorial Government.

"Resolved, That a copy of the above preamble and resolutions, together with a copy of the report of the committee on credentials, be forwarded to the President of the United States, each of the heads of the departments of the general government, each of the members of the Senate and House of Representatives of the United States, and to the Governor, Secretary, Marshal, Librarian, Auditor and Treasurer of the Territory of Minnesota."

On motion of Mr. BAKER, the further consideration of the resolutions was postponed until to-morrow, in order to give Mr. Gon-MAN an opportunity to address the Convention before their adoption.

Mr. BECKHR offered the following resolution, which was adopted :

"Resolved, That the use of this Chamber be given to Mr. C. W. COULDOCK, on Thursday evening, for a dramatic recitation, the same to be used under the supervision of the Sergeant-at-Arms of this Convention."

On Motion of Mr. GORMAN, the Convention adjourned until tomorrow at 10 o'clock, A. M.
