CO-ORDINATING GROUP ON A POLITICAL SETTLEMENT: FIFTH MEETING

The Co-ordinating Group met on Thursday.

Senator Mitchell's intervention to bring the negotiations to a swift conclusion is helpful, and should help to generate a sense of momentum in the public mind. We will be encouraging him to hold press briefings each evening after the talks in order to keep this going.

A poll conducted for the NI Information Service this week shows a mixed picture. There is strong support for those parties at the talks; but a big divide between Unionists and Nationalists as to how they intend to vote in the referendum (70% of Nationalists say they will vote 'yes', with 61% of Unionists undecided). We will continue to tailor our messages accordingly. We have some useful opportunities coming up, including a speech by my Secretary of State to a Women's Conference next week.

On the key issues which bear on an agreement, the main points were as follows:



- Referendum: the draft Order will be sent to parties next week; we need to resolve, with the Cabinet Office, propriety issues as a matter of urgency;
- elections: a number of policy issues need to be resolved with the parties, in particular, the electoral system;
- police reform: we have prepared a more detailed paper on the Commission which could be played into the talks next week;
- · prisons: the Narey report will be made public next week;
- decommissioning: the issue has dominated the talks this week, and
 parties will return to it on Monday at the resumed (time-limited) plenary;
 the Commission is seeking authorised contacts to be nominated with
 paramilitary groups this would be a positive development, but may not
 be achieved by Monday (Adams is resisting it);
- rights: we are continuing to refine our proposals on a Commission;
 identifying rights in addition to the ECHR remains difficult (a fallback option would be to remit the issue to the Commission once established);
- equality: proposals on flags and emblems, and the Irish language are before Ministers;
- parades: the Commission have helpfully decided to delay until 23 April
 giving their preliminary view on a number of contentious parades; the
 decision on the Ormeau Road march scheduled for 13 April will be made
 by 3 April; the Lower Ormeau Resident's Group are in the process of
 seeking a judicial review of the Commission membership;
- normalisation: the sub-committee on confidence building measures
 considered the Government's paper on security issues on Tuesday; the
 paper emphasised that the Government aspires to full normalisation, but
 that the rate of this is necessarily dependent on the assessment of the level
 of threat;



- Bloody Sunday: the Inquiry's planned visit to Londonderry on 3 April has attracted interest this week; internally, we are considering media handling when the Inquiry's work begins in earnest;
- NIO post-settlement: planning for various scenarios continues, constrained in some cases by lack of clarity about the precise terms of a settlement;
- NI departments post-settlement: work on accommodation, staffing and structures continues;
- consolidating the agreement: we have established a working group to generate ideas to respond to the offers of US assistance.
